27	the Fraternal Order of Police Associates (Lodge #55, Hallandale); and

29	WHEREAS, the Curci family were pioneers of our community, settling in Hallandale in		
30	1907 and building the historical Villa Providence in 1924; and

32	WHEREAS, Frank Anthony Curci, with his wife Rosina settled in Hallandale Beach on SW		
33	5th Avenue and West Dixie Highway. As a pioneer family, they struggled, yet grow prosperous b		
34	reinvesting their farming profits into land purchases, which they used for additional tomato fiel		
35	and fruit groves; and

37	WHEREAS, the Mayor and City Commission determined by a 3/2 vote on May 4, 2016 to		
38	co-designate NW 2nd Avenue to NW 2 nd Avenue - Joe Lewis Smith Avenue and SW 2nd Avenue
