RESOLUTION NO. 2013 - 25

A RESOLUTION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR LANDSCAPING AND IRRIGATION MAINTENANCE FOR STATE ROAD A1A (SOUTH OCEAN DRIVE), STATE ROAD 9 (I-95 RAMP EXIT), STATE ROAD 824 (PEMBROKE ROAD), STATE ROAD 858 (HALLANDALE BEACH BOULEVARD) AND STATE ROAD 5 (FEDERAL HIGHWAY); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Transportation requires the execution of a Maintenance Memorandum of Agreement (MMOA) prior to issuance of a permit to perform construction in the right of way of State Roads; and

WHEREAS, execution of the MMOA ensures proper landscaping and irrigation maintenance in the medians by the City for all State Roads located within the City limits; and

WHEREAS, the City has plans to install landscaping and irrigation systems on State Road A1A (South Ocean Drive), State Road 5 (Federal Highway), State Road 9 (I-95 Ramp Exit), State Road 824 (Pembroke Road) and State Road 858 (Hallandale Beach Boulevard); and

WHEREAS, the Florida Department of Transportation requires that the City enter into a Maintenance Memorandum of Agreement for maintaining improvements installed in the State's right-of-way; and

WHEREAS, City staff believes it is in the City's best interest to execute an agreement, as attached in Exhibit A, for maintaining the landscaping and irrigation systems installed in the State's right-of-way.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Manager Authorization. The Mayor and City Commission hereby authorize the City Manager execute a Maintenance Memorandum of Agreement, as attached in Exhibit A, with the Florida Department of Transportation for the maintaining of

landscaping and irrigation systems on State Road A1A (South Ocean Drive), State Road 5 (Federal Highway), State Road 9 (I-95 Ramp Exit), State Road 824 (Pembroke Road) and State Road 858 (Hallandale Beach Boulevard). The City Manager is authorized to take the necessary actions to implement the project.

SECTION 2. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
