30	Hallandale Beach for all charges and services rendered by the City, on or after October 1, 2016.

32	SECTION 2. City Manager is authorized to promulgate and publish such fees and
33	charges and shall insure the proper collection and accounting of all monies arising therefrom. In the
34	event of doubt or ambiguity, the City Manager is authorized to determine the appropriate fee.
35	SECTION 3 . The City Manager is authorized to revise the appropriate fee(s) when
36	additional fees or charges are required by Broward County or the Florida State Legislature.
37	SECTION 4. This Resolution shall take effect immediately upon its passage and
38	adoption.
