4 5 6 7 8 9 10 11 12 13	A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING THE 2017 AMENDMENTS TO THE THREE (3) EXISTING INTERLOCAL AGREEMENTS BETWEEN BROWARD COUNTY AND THE CITY OF HALLANDALE BEACH FOR THE DIVISION AND DISTRIBUTION OF THE PROCEEDS OF LOCAL OPTION GAS TAXES IMPOSED BY BROWARD COUNTY; AND PROVIDING AN EFFECTIVE DATE.
14	WHEREAS, Broward County and the Cities in the County have entered into three
15	(3) Interlocal Agreements ("ILA's") providing for the division and distribution of the
16	proceeds of the local option gas taxes imposed by Broward County by ordinance; and
17	
18	WHEREAS, the original local option gas tax levied in 1988 provides for cities
19	throughout Broward County to receive 37.5 percent of the proceeds of a six (6) cent gas
20	tax; and
21	WHEREAS, the Finance Department is responsible for the Financial Management
22	and Planning of the City, and this includes establishing and maintaining effective controls
23	of financial activities, providing financial information to outside auditors and local, state,
24	and federal agencies; and
25	
26	WHEREAS, the additional local option gas tax levied in 1994 provides for Broward
27	County cities to receive 51.27 percent of a three (3) cent gas tax; and
28	
29	WHEREAS, the transit gas tax levided in 2001 provides for Broward County cities
30	to receive 26 percent of the proceeds of a one (1) cent gas tax; and
31	
32	WHEREAS the distribution of local option gas taxes as provided for by the ILAs
33	are based on population figures published annually by the University of Florida Bureau of
34	Economics and Business Research; and
35	
36	WHEREAS, the ILAs authorize the annual revision of city shares in the local option
37	gas tax proceeds based on the most current published population numbers; and
38	

39	WHEREAS, the City and County's populations have increased, creating the need
40	to adjust its cities' shares of the local option gas tax proceeds; and
41	
42	WHEREAS, the proposed 2016 amendments to the existing ILAs (the
43	"Amendments") adjust the City's share of the local option gas tax proceeds based on the
44	population increases in the City and in Broward County; and
45	
46	WHEREAS, the City Administration recommends approval of the Amendments in
47	the forms attached hereto as Broward County Exhibits "1", "2" and "3"; and
48	
49	WHEREAS, the Mayor and City Commission have determined that it is in the best
50	interest of the residents of the City of Hallandale Beach to execute the 2016 amendments
51	to the three (3) existing Interlocal Agreements with Broward County for the division and
52	distribution of the proceeds of the local option gas taxes imposed by Broward County in
53	the forms attached hereto as Broward County Exhibits "1", "2" and "3"; and

55	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
56	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
57	
58	SECTION 1. City Manager Authorization. The Mayor and City Commission
59	hereby authorize the City Manager to execute the three (3) amendments to the Interlocal
60	Agreements with Broward County for the division and distribution of the local option gas
61	taxes imposed by Broward County, in the forms attached hereto as Broward County
62	Exhibits "1", "2" and "3"; and
63	
64	SECTION 2. This Resolution shall take effect immediately upon its passage and
65	adoption.
