A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA, APPROVING ONE YEAR RENEWALS OF CONTRACT ITB #2011-12/22 WITH FERGUSON ENTERPRISES, INC., FORTILINE WATERWORKS, INC., HD SUPPLY WATERWORKS LTD, LEHMAN PIPE AND SUPPLY, INC. FOR WATER METER FITTINGS AND WATER LINE ACCESSORIES FOR THE AMOUNTS APPROPRIATED IN THE CURRENT YEAR'S BUDGET

WHEREAS, the City currently utilizes the contract to purchase Water Meter Fittings and Water Line Accessories for the Utilities Maintenance Division; and

WHEREAS, this is a cooperative contract with other participating governmental agencies, in which the City of Deerfield Beach is the lead agency; and

WHEREAS, the initial contract terms were for three (3) years, beginning on November 1, 2012 and ending on October 31, 2015; and

WHEREAS, the terms and conditions of the contracts provided for three (3) additional one (1) year renewal options; and

WHEREAS, the City wishes to exercise the right to extend the contracts for the second (2nd) of the three (3) renewal periods; and

WHEREAS, the term of the second (2nd) contract renewals are for one (1) year, beginning November 1, 2016 and ending October 31, 2017; and

WHEREAS, Staff recommends that the City Commission approve one (1) year renewals of the contracts for Ferguson Enterprises, Inc., Fortiline Waterworks, Inc., HD Supply Waterworks LTD, Lehman Pipe and Supply, Inc.;
