17	budget anytime during the fiscal year or within sixty (60) days after the end of the fiscal			
18	year for which the budget applied; and

20	WHEREAS, on May 21, 2014, the City Commission approved Resolution 2014-			
21	48, authorizing the City to submit the Facilities Plan to the Florida Department of			
22	Environmental Protection for approval and initiative of the State Revolving Fund process;			
23	and			
24	WHEREAS, on December 2, 2015, Ordinance No. 2015-16 was approved for the			
25	State Revolving Fund loan program, authorizing the City Administration to make findings,			
26	authorize the loan application and agreement, establish pledged revenues, designate			
27	authorized representatives for the loan; and

29	WHEREAS, the City and FDEP executed the loan agreement for the total amount			
30	of state financial assistance of five hundred fifty thousand (\$550,000.00) dollars; and

32	WHEREAS, the City Administration proposes that the FY 2015-2016 adopted			
33	budget be amended to include the revenue, expenditures and related transactions			
34	associated with the State Revolving Loan Agreement #WW061720 in the amount of five			
35	hundred fifty thousand (\$550,000.00) dollars; and

37	WHEREAS, this budget amendment will increase the FY 2016-2017 adopted			
38	budget as indicated in Exhibit 5 of this ordinance; and
