9 10	MATERIALS FROM HD SUPPLY WATERWORKS IN AN AMOUNT NOT TO EXCEED NINETY THOUSAND (\$90,000.00)
11	DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE
12 13	ANY AND ALL DOCUMENTS TO EFFECTUATE THE PURCHASE; AND PROVIDING AN EFFECTIVE DATE.
14	TORONACE, ARE I ROVISING AR ELIZENTE BATE.
15 16	WHEREAS, various Divisions within the Department of Public Works purchase plumbing
17	supplies, water upgrade materials, piping, valves and fittings and water meters and meter fittings
18	from HD Supply Waterworks; and
19	
20	WHEREAS, the City of Deerfield Beach acts as the lead agency on behalf of the Southeast
21	Florida Governmental Purchasing Cooperative Group (Southeast Co-op) competitively solicited
22	bids for the purchase of water meter fittings and water line accessories; and
23	
24	WHEREAS, the City is an active participant agency in the Southeast Co-op, therefore the
25	City may participate in this contract; and
26	
27	WHEREAS, the City has spent forty nine thousand three hundred nineteen (\$49,319.00)
28	dollars, to date this fiscal year; and
29	
30	WHEREAS, it is expected that the City Manager's purchasing threshold with HD Supply
31	Waterworks will be reached before the end of FY16-17 due to additional anticipated purchases;
32	and
33	WHEREAS, in addition to general purchases through the Co-op contract, the City is in the
34 35	process of upgrading water meters throughout the City, and HD Supply Waterworks is the
36	exclusive authorized distributor of Sensus products for the state of Florida; and
37	exclusive dutionzed distributor of census products for the state of Florida, and
38	WHEREAS, Pursuant to Chapter 23, Section 23-7 (3) Noncompetitive Supplies, of the
39	City of Hallandale Beach Code of Ordinances, the City Manager is authorized to purchase and
40	contract for noncompetitive supplies (supplies, available only from one source, such as unique,
41	patented or franchised supplies) in excess of fifty thousand (\$50,000) dollars, provided authorized

42	funds are available in the annual budget and records of purchases exceeding \$50,000 are
43	available for review in the Procurement Department; and
44	
45	WHEREAS, the City Administration anticipates an additional expenditure of forty thousand
46	six hundred eighty two (\$40,682.00) dollars for a total expenditure this fiscal year of ninety
47	thousand (\$90,000.00) dollars, inclusive of water meters; and
48	
49	WHEREAS, the City Administration recommends that the City Commission authorize the
50	expenditure for a total amount not to exceed ninety thousand (\$90,000.00) dollars this fiscal year
51	from HD Supply Waterworks to purchase plumbing supplies, water upgrade materials, piping,
52	valves and fittings and water meters and meter fittings, and authorizing the City Manager to
53	execute any and all documents to effectuate the purchase; and
54	
55	WHEREAS, the Mayor and City Commission have determined that the City
56	Administration's recommendations are in the best interest of the City and its residents.
57	
58	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
59	THE CITY OF HALLANDALE BEACH, FLORIDA:
60	
61	SECTION 1 . The foregoing "Whereas" clauses are incorporated herein.
62	
63	SECTION 2. City Manager Authorization. The Mayor and City Commission hereby
64	authorize the City Manager to expend the funds for a total amount not to exceed ninety thousand
65	(\$90,000.00) dollars this fiscal year from HD Supply Waterworks to purchase plumbing supplies,
66	water upgrade materials, piping, valves and fittings and water meters and meter fittings, and
67	authorizing the City Manager to execute any and all documents to effectuate the purchase.
68	
69	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
70	passage and adoption.
