RESOLUTION NO. 2017 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, ESTABLISHING THE TENTATIVE MILLAGE RATE; AND ESTABLISHING THE TENTATIVE MILLAGE RATE FOR THE DEBT OBLIGATION FOR THE PARKS AND RECREATION GENERAL OBLIGATION (GO) BOND; FIRE ASSESSMENT RATES; AND LOT MAINTENANCE ASSESSMENT FIGURES FOR FISCAL YEAR 2017-2018; AND SETTING THE DATE, TIME AND PLACE OF PUBLIC HEARINGS TO CONSIDER THE TENTATIVE MILLAGE RATES; FIRE ASSESSMENT RATES; AND LOT MAINTENANCE ASSESSMENT FIGURES AND TENTATIVE BUDGET; PROVIDING FOR DIRECTIONS TO THE CITY CLERK; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, Chapter 200, Florida Statutes, provides for a uniform procedure for the adoption of ad valorem tax and millage rates associated therewith; and

**WHEREAS**, Chapter 170, Florida Statutes, provides for a special assessment to fund capital improvements and municipal services, including fire protection; and

**WHEREAS**, Chapter 197, Florida Statutes, provides for an alternative method of collection of non-ad valorem assessments, including lot maintenance assessments; and

**WHEREAS**, Section 200.065, Florida Statutes, provides for the adoption of a tentative millage rate, together with the establishment of a rolled-back rate computed pursuant to Section 200.065(1), Florida Statutes; and

**WHEREAS**, on June 1, 2017, the Property Appraiser of Broward County, Florida served upon the City a Certification of Taxable Value, certifying to the City its estimated 2017 taxable value; and

**WHEREAS**, the Truth-in-Millage (TRIM) legislation requires the City to submit the Certification of Taxable Value (Form DR-420) to the County Property Appraiser no later than August 4, 2017, along with the tentative millage rate; the rolled-back millage rate; and the date, time and location of the first public hearing; and

40           **WHEREAS**, pursuant to applicable provisions of law, the electorate of the City of  
41 Hallandale Beach has voted to authorize the issuance of general obligation debt for parks  
42 and recreation projects; and

44           **WHEREAS**, tax needs to be levied for Fiscal Year 2017-2018 to provide funding  
45 for the payment of Voted Debt Service; and

47           **WHEREAS**, it also requires municipalities that have special assessments to  
48 advise the appropriate agencies of the total amount to be collected for that special  
49 assessment and the date, time and location for the public hearings.

51           **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
52 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

54           **SECTION 1. Adoption of Representations.** The foregoing whereas  
55 paragraphs are hereby ratified and confirmed as being true, and the same are hereby  
56 made a specific part of this Resolution.

58           **SECTION 2. Adoption of Tentative Millage Rate.** The Mayor and City  
59 Commission hereby adopt and establish the tentative millage rate for FY 2017-2018 at  
60 5.3093 mills, which is \$5.3093 per \$1,000.00 of assessed property within the City of  
61 Hallandale Beach, Florida.

63           **SECTION 3. Computation of Rolled-back Rate.** The rolled-back rate is 4.9521  
64 mills as computed utilizing the June 1<sup>st</sup> Estimate of Taxable Value.

66           **SECTION 4. Adoption of Parks General Obligation (GO) Bond Tentative**  
67 **Millage Rate.** The Mayor and City Commission hereby adopt and establish the Parks GO  
68 Bond tentative millage rate for FY 2017-2018 at .4905 mills, which is \$.4905 per \$1,000.00  
69 of assessed property within the City of Hallandale Beach, Florida.

71           **SECTION 5. Adoption of Fire Assessment Rate.** The Mayor and City  
72 Commission hereby adopt and establish the Fire Assessment rate at \$198.00 per year for  
73 residential and all other classifications accordingly.

**SECTION 6. Adoption of Lot Maintenance Assessment.** The Mayor and City Commission hereby adopt the Lot Maintenance assessments as may be adjusted accordingly.

**SECTION 7. The Establishment of date, time and location of public hearings.** The date, time and place of the first and second public hearings on the proposed millage rate and budget; Fire Assessment rate and Lot Maintenance Assessment are set by the Mayor and City Commission as follows:
