4 AN ORDINANCE OF THE MAYOR AND CITY COMMISSION OF
5 THE CITY OF HALLANDALE BEACH, FLORIDA, AMENDING
6 CHAPTER 2 ADMINISTRATION, ARTICLE II CITY COMMISSION,
7 SECTION 2-31 OF THE CODE OF ORDINANCES, ENTITLED
8 COMPENSATION AND EXPENSES OF THE CITY COMMISSION
9 TO REVISE THE PROCESS FOR SETTING OF COMPENSATION;
10 PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICT;
11 PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN
12 EFFECTIVE DATE.

14 WHEREAS, the Mayor and City Commission find that the City's Code of Ordinances
15 providing for the compensation and expenses of the City Commission should be revised to
16 permit for consideration of the matter by way of resolution at any time outside the budget
17 process and to remove reference to percentages.

19 NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COMMISSION
20 OF THE CITY OF HALLANDALE BEACH, FLORIDA:

22 **SECTION 1.** Chapter 2 Administration, Article II. City Commission, Section 2-31,
23 Compensation and expenses of the City's Code of Ordinances is amended to read as
24 follows:

25 **ARTICLE II. CITY COMMISSION**

26 Sec. 2-31. Compensation and expenses.

27 The commission ~~at the annual review of the budget,~~ may determine the annual salary, ~~but~~
28 ~~not in excess of ten percent~~ of commissioners ~~current salary~~ by majority vote of the
29 commission either as part of the annual approval of the budget or, at any other time, by
30 resolution if no overall increase to the general fund is required, or ordinance if an overall
31 increase to the general fund is required. If the commission takes no action, the salary shall
32 be adjusted (COLA) as part of the budget process each year at the same rate of increase as
33 that of city employees. Commissioners shall receive their actual and necessary expenses
34 incurred in the performance of their duties of office as preauthorized by the city commission.
35

36 **SECTION 2. Conflict.** All ordinances or portions of the Code of Ordinances of the
37 City of Hallandale Beach in conflict with the provisions of this ordinance shall be repealed to
38 the extent of such conflict.

39 **SECTION 3. Severability.** Should any provision of this ordinance be declared by a
40 court of competent jurisdiction to be invalid, the same shall not affect the validity of the
41 ordinance as a whole, or any part thereof, other than the part declared to be invalid.

42 **SECTION 4. Codification.** It is the intention of the Mayor and the City Commission
43 that the provisions of this ordinance be incorporated into the Code of Ordinances; to effect
44 such intention the words "ordinance" or "section" may be changed to other appropriate
45 words.

46 **SECTION 5. Effective Date.** This Ordinance shall take effect immediately upon
47 adoption on second reading.
