16 17	WHEREAS, in 2014, the City retained EAC Consulting, Inc., ("EAC") to complete a
18	conceptual design for the Diana Drive Improvement project utilizing the Continuing Services and
19	Comprehensive Services RFP #2007-2008-004; and
20	
21	WHEREAS, the project will provide landscape and drainage solutions, and implement
22	divided traffic between the frontage road and Diana Drive; and
23	
24	WHEREAS, in 2015, the City Commission authorized EAC to expand the final conceptual
25 26	design that had already been completed in order to include civil engineering design, permitting, and limited post design services that would be utilized for the Diana Drive improvements. The
27 28 29	work authorization was authorized pursuant to Continuing Services Agreement #2013-2014-006 in an amount of eighty nine thousand three hundred (\$89,300.00) dollars; and
30	WHEREAS, the City Commission requested a property survey of the area in order to
31	determine available City property that could be reclaimed in order to build a sidewalk on the north
32	side of the road in addition to the proposed sidewalk on the south side, and to construct bike lanes
33	on both sides within the City's right of way; and

35	WHEREAS, Section 23-6, Award of Contract, provides that the City Manager shall have
36	the authority to recommend to the City Commission the award of contracts; and

38 39 40	WHEREAS, the City Administration recommends that the Mayor and City Commission authorize the City Manager to approve the updated Diana Drive design proposal and to issue an increase in the work authorization to EAC Consulting. Inc. in the amount of twenty six thousand

WHEREAS. the Mayor and City Commission have determined that it is in the best interest of the City and its residents to authorize the City Manager to approve the updated Diana Drive design proposal and to issue an increase in the work authorization to EAC Consulting, Inc. in the amount of twenty six thousand one hundred sixty five dollars (\$26,165.00) to provide these services for a total amount not to exceed one hundred fifteen thousand four hundred sixty five (\$115,465.00) dollars.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Manager's Authorization. The Mayor and City Commission hereby authorize the City Manager to approve the updated Diana Drive design proposal and to issue an increase in the work authorization to EAC Consulting, Inc. in the amount of twenty six thousand one hundred sixty five (\$26,165.00) dollars to provide these services for a total amount not to exceed one hundred fifteen thousand four hundred sixty five (\$115,465.00) dollars. The City Manager is authorized to take necessary action to execute the authorization.

SECTION 2. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
