### 1. CALL TO ORDER

*The meeting was called to order at 6:47 PM.*

### 2. ROLL CALL

**Present:** 4 - Mayor Cooper, Commissioner Lazarow, Vice Mayor London and Commissioner Sanders

**Absent:** 1 - Commissioner Taub

*City Manager Roger Carlton and City Attorney Jennifer Merino were also present.*

### 3. PLEDGE OF ALLEGIANCE

### 4. ORDER OF BUSINESS

*Mayor Cooper advised that Item 13A is time certain for 7:00 pm and requested that Item 10B be heard prior to Item 13A.*

**A motion was moved by Commissioner Lazarow, seconded by Commissioner Sanders, to hear Item 10B prior to Item 13A. The motion carried unanimously 4-0.**

### 5. PUBLIC PARTICIPATION (Speakers must sign-in with the City Clerk prior to the start of the meeting)

*Alex Lewy, Hallandale Beach, FL, thanked Mayor Cooper, Commissioner Sanders, and Commissioner Taub for their support defeating a major development application for a private school that would have hurt residents of the southwest. Lastly, Mr. Lewy requested the Commission ensure the proposed decorum Ordinance does not violate public free speech rights.*

*City Clerk Bataille read into the record an e-comment from Russell Vermer of Hallandale Beach (exhibit 1). Mr. Vermer e-comment highlighted the following:*

- Timing on lights going east on Hallandale Beach Boulevard to get onto I-95 South.*
- City lawn workers parking their work truck in one of the two left and turning lanes to*

*get onto I-95 during rush hour.*

*City Manager Carlton concurred with Mr. Vermer's observation and indicated staff will meet with the Florida Department of Transportation to review the matter.*

## **6. PRESENTATIONS**

### **A. PROCLAMATION PROCLAIMING THE MONTH OF JUNE AS ALZHEIMER'S AND BRAIN AWARENESS MONTH. (SPONSORED BY JOY F. COOPER)**

*Mayor Cooper along with the City Commission presented Alexander Lewy, Director of Community Outreach for the Alzheimer's Association of Southeast Florida Chapter, with a Proclamation proclaiming the month of June as Alzheimer's and Brain Awareness Month.*

### **B. PRESENTATION OF RESILIENCE DIALOGUES PROGRAM (STAFF: PUBLIC WORKS DIRECTOR)**

*Sue Fassler, Green Initiative Coordinator, presented the item and answered questions posed by the City Commission.*

*Mayor Cooper spoke on the importance of raising this issue both locally and nationally. In addition, she made it known that the Broward County Chamber of Commerce are doing a Sustainability Committee comprised of City staff in all the Cities.*

*Mayor Cooper continued to speak in support of the Paris Accord.*

*City Manager requested the City Commission direct him to investigate the Paris Accord to determine which elements are important on a local level.*

*Consensus:*

*- To Grant the City Manager to investigate and report back to the Commission on adopting appropriate elements of the Paris Agreement on Climate Change*

*Vice Mayor London applauded staff for starting the Sustainability Action Plan without a consultant.*

*Vice Mayor London raised concerns considering Chaves Lake as part of the open space calculation, however it is closed to the public.*

*Vice Mayor London suggested additional research should be done with regards to re-nourishing beaches and restoring natural habitat as it may protect the shoreline.*

*Vice Mayor London requested staff to look into potential mitigation funding opportunities through the I-95 expansion project.*

*Vice Mayor London requested staff look into potential pre-disaster grant opportunities and mentioned the success the City of Golden Beach has had with receiving this type of grants.*

*Vice Mayor London requested staff contact Wayne Pathman of Pathman Lewis, LLC and Pat Davis of Hazen and Sawyer to provide a Workshop Item on resilience.*

*Vice Mayor London requested to staff to look into a potential partnership with FP&L to harden the 14th Avenue substation.*

*Mayor Cooper clarified Chaves Lake is part of the Parks Master Plan.*

## **7. COMMISSIONER COMMUNICATIONS - Items not on the Agenda**

### **A. COMMISSIONER LAZAROW**

*Answering a question posed by Commissioner Lazarow, Director Keven Klopp updated the Commission on 2000 South Ocean Drive and the beach access improvements associated with the project.*

*Answering a question posed by Commissioner Lazarow, Assistant City Manager Parkinson explained the NE drainage system was cleaned as part of the pump station project.*

*Commissioner Lazarow shared her car was recently broken into in her neighborhood.*

### **B. COMMISSIONER SANDERS**

*No communications.*

### **C. COMMISSIONER TAUB**

*No communications.*

### **D. VICE MAYOR LONDON**

*Answering a question posed by Vice Mayor London regarding the 2000 South Ocean Drive project, Director Klopp indicated scope of work has been reviewed and the draft report is underway.*

*Vice Mayor London indicated he has been contacted by condominium boards regarding vacation rental Ordinance and requested a future item to revise the Ordinance to include a registry for multifamily homes.*

*Vice Mayor London questioned if someone were to come to the City Attorney for an opinion and forgot or did not want to provide a fact, if that would matter in the long run and how would it affect the case.*

*City Attorney Merino stated that omitting a material fact would affect a legal analysis of any legal question and render the legal opinion invalid.*

*Vice Mayor London mentioned a murder that happened in the Northwest, and was made aware that a police officer was sitting there on eight-hour shift. Vice Mayor London questioned if that is true and if that is a good opportunity for resources.*

*Police Chief Flournoy replied that police officers sitting on eight-hour shift are a good utilization of resources. From what has been experienced, the amount of resources put in that area to initially abate the area and bring some calm and safety to that block.*

*City Manager Carlton indicated that this is a murder investigation and if there are any questions it would be best to discuss them with the Chief one on one, not in a public forum.*

*Vice Mayor London shared a public hearing notice for the City of Aventura regarding a Water Ways Park and a two-acre parcel that would be given to the City by Gulfstream for a school. He believed this was a lost opportunity for the City. He further shared his concerns of a past bill from Shutts & Bowen LLP for a potential imminent domain procedure.*

*City Manager Carlton clarified the bill from Shutts & Bowen LLP was inclusive of a study of right-of-way for a road, which the City does have.*

*Answering a question posed by Vice Mayor London, Director Klopp updated the Commission on a Local Planning Agency Public Hearing in Aventura concerning Gulfstream application for amendment to official zoning map. City Manager Carlton added staff would attend the meeting if desired by the Commission.*

*Answering a question posed by Vice Mayor London, City Manager Carlton stated staff will look into the complaint received regarding unauthorized former City employees visiting the Public Works site.*

*Answering a question posed by Vice Mayor London, City Manager Carlton advised the Commission on the summer schedule.*

*Answering a question posed by Vice Mayor London, City Manager Carlton updated the Commission on the future Lobbyist RFP (Request for Proposal).*

*Answering a question posed by Vice Mayor London, City Manager Carlton advised there are no plans to outsource the services of the Hepburn Center.*

*Answering a question posed by Vice Mayor London concerning the proposed decorum Ordinance, City Clerk Bataille advised a sample summary of the decorum Ordinance will be provided as part of the 2nd reading of the Ordinance.*

**E. MAYOR COOPER**

*Mayor Cooper congratulated Adriana Ozline of Sign O Rama for receiving the Small Business Leader of the Year Award.*

*Mayor Cooper referenced the Hepburn Center and Elderly Appropriations and questioned how the fair shares are being handled.*

*Deputy City Manager Rafols confirmed the shares were included in the budget as a line item which would require Commission approval.*

*Mayor Cooper requested staff to reach out to Broward Health Funding as this year's match funding is \$10,000.*

*Mayor Cooper advised that while in attendance at the Broward League Inflation Dinner, it was mentioned that Broward College will be coming to the Broward Center of Excellence in December.*

*Mayor Cooper thanked City Attorney Merino and Police Chief Flournoy for their work Ordinance regarding posting the Medical Malpractice issue about the person who was blind and could read in Braille. She suggested a partnership with the Americans with Disabilities to see if there is a brochure that could be inserted with the renewal of Business Tax Receipts.*

*Mayor Cooper mentioned a meeting on the improvement of I-95 South of Hallandale Beach Boulevard to North of Hollywood Boulevard. She noted the meeting was about capacity and there was discussion about possibly doing an elevated loop.*

*City Manager Carlton indicated that a full report will be provided at the Workshop this month.*

*Mayor Cooper commended Police Chief Flournoy for his service to the City.*

*Answering a question posed by Mayor Cooper, City Manager Carlton updated the Commission on the recruitment process for the new Police Chief.*

*Mayor Cooper requested the City Manager have a member of staff join the June 9, 2017 conference regarding Drone Policy & Safety.*
