20	WHEREAS, throughout most of Hallandale Beach's history the City has envisioned
21	the Fashion, Art and Design (FAD) District to be a destination for local art, fashion, design,
22	dining and more; and
23	
24	WHEREAS, the designation of "Special District" for the area located at NE 1st
25	Avenue from Hallandale Beach Boulevard to NE 5th Street and the properties that front
26	the area will further promote the district as a destination within the community; and
27	
28	WHEREAS, the Florida Department of Transportation ("Department") and Broward
29	County Traffic Engineering Division (BCTED) are working to advance trailblazer routes to
30	the FA&D on state roads; and
31	
32	WHEREAS, a special district designation will allow the Department and BCTED to
33	implement a signage and wayfinding concept plan to redirect traffic to NE 1st Ave if
34	northbound left-turn movements are restricted on Hallandale Beach Boulevard; and

37	WHEREAS, at the direction of City Manager Roger Carlton, both the Department
38	and BCTED have begun working on trailblazing signage conceptual plans.

40	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY
41	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

43	SECTION 1. The foregoing "Whereas" clauses are hereby incorporated fully
44	herein.

46	SECTION 2. The Mayor and City Commission of Hallandale Beach authorize the
47	creation of the designation of "Special District" to be known as the "Hallandale Beach
48	Fashion, Art, & Design District" (FAD District) for the area located at NE 1st Avenue from
49	Hallandale Beach Boulevard to NE 5 th Street and the properties that front the area.
50	
51	SECTION 4 . The Mayor and City Commission authorize and support the Florida
52	Department of Transportation and Broward County in their efforts to create trailblazer
53	routes from state roads to the new district with signage and wayfinding.
54	
55	SECTION 5. The City Clerk is directed to provide a copy of this Resolution to the
56	Florida Department of Transportation and Broward County.
57	
58	SECTION 6. This Resolution shall take effect immediately upon its passage and
59	adoption.
