16	WHEREAS, the City and PRH Beackwalk Beachclub, LLC ("PRH") entered into an
17	Operating and Management Agreement ("the agreement") for the redevelopment and operation
18	of the City's North Beach Park and its restaurant; and
19	WHEREAS, on March 1, 2017 the City entered into an amendment of the agreement to
20	replace the former Restaurant Operator with Beach-Chu Hallandale, LLC; and
21	WHEREAS, as part of the conversion to Etaru, the North City Beach Park Building will
22	undergo renovation to refresh its furniture, fixtures, and equipment including the installation of the
23	robata grill in the center of the restaurant; and
24	WHEREAS, the City will receive a proportion of revenue, as per Section 29 of the
25	Operating and Management Agreement, and has a significant interest in ensuring the quality of
26	operations and the maximization of revenue; and
27	WHEREAS, the City Administration seeks City Commission authorization to engage in a
28	"soft-opening" whereby the restaurant will be open only to certain individuals, corporate affiliates
29	and suppliers to test the newly hired staff, kitchen operations, and service requirements of
30	updated facility once construction is complete; and
31	WHEREAS, the City Administration requests the Mayor and City Commission authorize

the City Manager to select participants from city officials, staff and their guests to participate in the soft-opening exercises which are planned for August 17, 18, 19 and 20, 2017 as part of the services rendered pursuant to the Operating and Management Agreement with PRH Beachwalk

54	Beachwalk Beachclub, LLC. PRH-2600 Hallandale Beach LLC, and Beach-Chu Hallandale LLC
55	as the subcontractor to operate the City's North Beach Park Restaurant.

57	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
58	passage and adoption.
