- Section 2. <u>Approval of Interlocal Agreements</u>. - Section 3. <u>Execution of Interlocal Agreements</u>. The HBCRA Executive Director is hereby authorized to execute the Interlocal Agreements.
- Section 4. <u>Implementation of Interlocal Agreements</u>. The HBCRA Executive Director is hereby authorized to take all steps necessary and appropriate to implement the terms and conditions of the Interlocal Agreements, but not limited to, making payments to the City.
