4 5 6 7 8 9 10 11	A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, VACATING CERTAIN PLATTED UTILITY EASEMENTS LOCATED AT THE OLD FEDERAL HIGHWAY PLAT, AUTHORIZING THE CITY MANAGER TO EXECUTE A TERMINATION AND RELEASE OF UTILITY EASEMENTS; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
13	WHEREAS, the City of Hallandale Beach has applied to vacate certain platted utility
14	easements located at the 601 Old Federal Highway Plat parcel, including a twelve (12) feet utility
15	easement along the northwest property line and a ten (10) feet utility easement for drainage along
16	the east property line, more particularly described in "Sketch and Description Vacation of Utility
17	Easements" (Exhibit "1-A"); and
18	WHEREAS, section 25-103 of the Hallandale Beach Code of Ordinances provides that a
19	petition for vacation of an easement may be granted or denied by resolution following notice and
20	a public hearing by the City Commission; and
21	WHEREAS, section 25-103 of the Code provides that if approval of other governmental
22	bodies is necessary for such vacation, such approval shall not be final until all other governmental
23	bodies have approved such vacations; and
24	WHEREAS, the easements sought to be vacated are located within the 601 Old Federal
25	Highway Plat which were approved by the City Commission and Broward County Commission.
26	Therefore, in addition to City Commission approval, vacation of the easement will require Broward
27	County Commission approval; and
28	
29	WHEREAS, it is anticipated Broward County may take approximately three (3) months to
30	complete the process, and the City's approval of the easement vacation will become effective
31	upon approval by the Broward County Commission; and

33	WHEREAS, no public interest will be adversely affected by termination of said portion of
34	the Utility Easement.

36	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
37	THE CITY OF HALLANDALE BEACH, FLORIDA:

39	<b>SECTION 1.</b> The foregoing "whereas" clauses are incorporated herein.
40	
41	SECTION 2. Mayor and City Commission Findings. The Mayor and City Commission
42	finds that the vacation provided for in this resolution will not adversely impact any property or the
43	general public and no present or reasonably foreseeable need exists for the vacated land.
44	
45	SECTION 3. City Manager Authorized. The Mayor and City Commission hereby
46	authorize the City Manager to execute a termination and release of easement, in form and
47	substance similar to "Termination and Release of Utility Easements" attached hereto as
48	Attachment "A", to vacate certain platted utility easements located at the 601 Old Federal Highway
49	Plat parcel, including a twelve (12) feet utility easement along the northwest property line and a
50	ten (10) feet utility easement for drainage along the east property line, more particularly described
51	in "Sketch and Description Vacation of Utility Easements" (Exhibit "1-A").
52	
53	SECTION 3. Recording of Termination and Release. Upon execution of one (1)
54	original "Termination and Release of Utility Easements", the City Clerk shall record the
55	"Termination and Release of Utility Easements" in the Public Records of Broward County, and
56	upon recordation, the original shall be retained by the City Clerk as a public record.
57	
58	SECTION 6. Providing for Conflict. All ordinances or parts of ordinances and all
59	resolutions or parts of resolutions in conflict herewith are hereby repealed.
60	
61	<b>SECTION 7</b> . <b>Providing for Severability</b> . In the event that any section or provision of
62	this ordinance or any portion thereof, any paragraph, sentence or word be declared by a court of
63	competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder
64	hereof as a whole or part thereof other than the part declared to be invalid.
65	
66	SECTION 8. Providing for Effective Date. This ordinance shall take effect upon
67	adoption.
