

RESOLUTION NO. 2014 - 23

A RESOLUTION OF THE CITY OF HALLANDALE BEACH, FLORIDA,
AUTHORIZING THE CITY MANAGER TO EXECUTE A DISTRICT FOUR
(4) AMENDMENT NUMBER TWO (2) TO THE STATE OF FLORIDA
DEPARTMENT OF TRANSPORTATION LANDSCAPE INCLUSIVE
MEMORANDUM OF AGREEMENT FOR HALLANDALE BEACH
BOULEVARD FROM I-95 RAMP TO EAST OF NW 10TH TERRACE, FM
NO. 431960-1-58-01; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Hallandale Beach and the Florida Department of Transportation ("FDOT") are working together to enhance the City's main gateway located at I-95 and Hallandale Beach Boulevard with new landscaping that will complement the City's new entrance sign; and

WHEREAS, the project location consists of the drainage swales on the northeast and southeast corners of I-95 and Hallandale Beach Boulevard, including the median directly in between the two areas; and

WHEREAS, The City and FDOT are both partially funding the Project, the total estimated cost of which is One Hundred Sixty Thousand Two Hundred Sixteen Dollars and Forty Cents (\$160,216.40); and

WHEREAS, the drainage swales are located on FDOT right of way, and FDOT is granting the City Forty Eight Thousand Dollars (\$48,000.00) to assist in funding the project; and

WHEREAS, the City is responsible for the remaining funding in the estimated amount of One Hundred Twelve Thousand Two Hundred Sixteen Dollars and Forty cents (\$112,216.40); and

WHEREAS, the Florida Department of Transportation requires the execution of a Maintenance Memorandum of Agreement (MMA) prior to issuance of a permit to perform improvements in the right-of-way of State Roads; and

WHEREAS, execution of the MMA ensures proper landscaping and irrigation maintenance in the medians by the City for all State Roads located within the City limits; and

38 **WHEREAS**, this is an amendment to an existing City wide landscaping MMOA, which will
39 include all of the landscaping pertaining to this project; and

41 **WHEREAS**, City administration believes it is in the City's best interest to execute a District
42 Four (4) Amendment Number Two (2) to State of Florida Department of Transportation Landscape
43 Inclusive Memorandum of Agreement, as attached in Exhibit A, for maintaining the improvements
44 installed in the State's right-of-way.

46 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
47 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

49 **SECTION 1. City Manager Authorization.** The Mayor and City Commission
50 hereby authorize the City Manager to execute a District Four (4) Amendment Number Two (2) to
51 State of Florida Department of Transportation Landscape Inclusive Memorandum of Agreement,
52 as attached in Exhibit A, with the Florida Department of Transportation for the maintaining of
53 improvements for Hallandale Beach Boulevard from I-95 Ramp to East of NW 10th Terrace, FM
54 Number 431960-1-58-01. The City Manager is authorized to take the necessary actions to
55 implement the project.

57 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its
58 passage and adoption.
