16 17	WHEREAS, pursuant to Section 23-4 of the City of Hallandale Beach Code, all purchases
18	of and contracts for equipment, supplies and contractual services, when the estimated cost shall
19	exceed \$50,000.00 shall be based wherever possible on competitive bids; and

21	WHEREAS, in preparation for the 2018 State Legislative Session, City Administration
22	released a Request for Proposal (RFP) #FY 2016-2017-010, State Lobbyist Services on July 5,
23	2017 to retain the services of a State Lobbyist Firm to assist with a variety of issues affecting the
24	City and its residents at a State level; and
25	WHEREAS, the City Administration conducted a competitive solicitation and obtained
26	proposals from four (4) vendors; and
27	
28	WHEREAS, the Request for Proposals notice was sent to thirty-eight (38) vendors from
29	the City's vendor list, and was advertised on City website, DemandStar website, and other
30	sources; and

32	WHEREAS, the Evaluation Committee reviewed the firms' submissions and held oral
33	presentations for top ranked firms on August 24, 2017. Ballard Partners, Inc. was the highest
34	ranked firm; and
35	WITERFAC the City Administration recommends that the City Commission eward DED
36 27	WHEREAS, the City Administration recommends that the City Commission award RFP
37 38	FY #2016-2017-010, State Lobbyist Services, to the highest ranked firm Ballard Partners, Inc. for a one year term in an amount not to exceed sixty thousand (\$60,000.00) dollars with two optional

48	Commission hereby authorize the City Manager to negotiate and execute an agreement with
49	Ballard Partners, Inc. for a one year term in an amount not to exceed sixty thousand (\$60,000)
50	dollars with two optional one year extensions to be approved by the City Commission. The City
51	Manager is further authorized to execute all related documents to effectuate this project.

53	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
54	passage and adoption.
