IN THE AMOUNT OF \$109,842

This is a First Amendment to Agreement ("First Amendment"), made and entered into by and between: BROWARD COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY,"

and

CITY OF HALLANDALE BEACH, a municipal corporation of the State of Florida, hereinafter referred to as "CITY," collectively referred to as the "Parties."

RECITALS

WHEREAS, the Parties entered into an agreement ("Agreement") dated March 8, 2017, providing for funding and administration of a Community Development Block Grant project in CITY for infrastructure improvements; and

WHEREAS, the Parties desire to enter into a First Amendment to provide CITY with a nine (9) month extension in order to complete the Project; and

WHEREAS, this First Amendment is necessary and reasonable under the circumstances, and is in the best interest of the public; NOW, THEREFORE,

IN CONSIDERATION of the mutual terms, conditions, promises, and covenants hereinafter set forth, the Parties agree as follows:

1. The above recitals are true and correct and are incorporated herein as if set forth in full hereunder.
2. Article 9, Term of Agreement, shall be amended as follows:

The term of this Agreement shall commence retroactively to October 1, 2016, and shall end on ~~September 30, 2017~~ June 30, 2018, unless terminated earlier or extended pursuant to the terms of this Agreement. CITY may submit a written request for an extension to the term of this Agreement to the Division Director no less than ninety (90) days prior to the expiration date. In the event the Division Director approves an extension to the term of this Agreement, the Parties shall enter into an amendment as provided in Section 12.19.

3. Exhibit "C," Project Schedule/Timeline, is amended to extend the time for completion as provided in Exhibit "C-1," Project Schedule/Timeline, attached hereto and incorporated herein.
4. All other terms and conditions of the Agreement, not inconsistent herewith, shall remain in full force and effect and are to be performed at the level specified in the Agreement.
5. This First Amendment shall be executed in four (4) counterparts, each of which shall be deemed to be an original.
