All 27 revenues and interest carried forward from the Fiscal Year 2016-2017 Budget shall be 28 appropriated according to established guidelines and in accordance with applicable law.

29 Section 3. <u>Authority of Executive Director</u>. The Executive Director is hereby authorized 30 to take all action necessary to implement the Fiscal Year 2017-2018 Budget.

31 Section 4. <u>Effective Date</u>. This resolution shall take effect immediately upon approval.
