A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA SUPPORTING THE CAMPAIGN TO DEFEND LOCAL SOLUTIONS; PROVIDING FOR AN EFFECTIVE DATE.

# **Staff Summary:**

#### Background:

Commissioner Lazarow requested an Item for consideration by the City Commission supporting the Campaign to Defend Local Solutions.

Since January of 2017 the non-partisan effort known as the "Campaign to Defend Local Solutions" has been working to build a network of individuals, organizations, and elected officials working to counteract the preemption of local government home rule powers. The Campaign to Defend Local Solutions is working to increase public awareness of the national trend of state legislatures by increasingly preempting local governments through public education efforts such as:

- Inform the general public of the impact of preemption laws on their day to day lives.
- Working to support cities challenging preemption laws within the judicial system.

The State of Florida is a diverse state with localities requiring individual solutions. Therefore, challenges must often be met with unique local solutions that go above and beyond any State solution that may be too broad and nonresponsive to local needs. Even worse, corporate Lobbyist often convice Legislators to pre-empt local Ordinances that are appropriate to its jurisdiction and supported by local citizens.

By approving the attached Resolution, the City of Hallandale Beach will be the first City to support the Campaign to Defend Local Solutions exemplifying the City Commission's belief that protecting the policies of our community is paramount.
