16	in 2012. This resulted in Resolution 2013-132, which awarded the contract to Lou's Police
17	Distributors, Inc.; and

19	WHEREAS, the resolution authorized a contract for a three-year term and did not
20	provide for automatic authorization of two additional one year renewals, contingent on good
21	performance; and
22	
23	WHEREAS, the City entered into a contract with the vendor dated November 15, 2013.
24	The contract provided for a three-year term with two one year renewals; and
25	
26	WHEREAS, the City extended the agreement for the first on year renewal, which
27	expired September 30, 2017; and
28	
29	WHEREAS, the City Administration request authorization to extend the agreement for
30	the final optional year in an amount budgeted at \$45,891 for uniforms and equipment to be
31	provided pursuant to the agreement attached as Exhibit "A" and further request City Manager
32	authorization to execute any and all necessary documents to implement the service; and

34	WHEREAS, the Mayor and City Commission have determined that the City
35	Administration's recommendations are in the best interest of the City and its residents.
