22	of \$50,000.00 requires City Commission approval; and
23	WILEDEAC on May 40, 2047, the Oity of Fort Loydondolo governed DED #575, 440,40
24	WHEREAS, on May 16, 2017, the City of Fort Lauderdale awarded RFP #575-11849
25	to Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc. for inspection and plar
26	review services for a 2-year term with 2 optional 1-year renewals; and

28	WHEREAS, the City of Hallandale Beach Building Division Summer Study conducted
29	in July 2017 revealed a substantial backlog in permit processing, thus demonstrating the need

50	as provided for in the fiscal year 2017-18 budget.
