3 4 5 6 7 8 9 10 11 12	A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, URGING THE UNITED STATES CONGRESS TO AMEND THE FINAL VERSION OF TAXREFORM LEGISLATION TO REMOVE THE LIMITATION ON STATE AND LOCAL GOVERNMENTS ABILITY TO ISSUE REFINANCE BONDS; DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO ALL APPROPRIATE PARTIES; DECLARING AN EFFECTIVE DATE.
13	WHEREAS, the United States Congress is currently negotiating the final version of tax-
14	reform legislation passed by the House and Senate that limit the ability of states and local
15	governments to refinance bonds; and
16	
17	WHEREAS, state and local governments issue both tax exempt and non-exempt bonds
18	to fund critical infrastructure including roads, utility projects, housing, parks and other projects
19 20	critical to local governments and their residents; and
21	WHEREAS, the bill provisions, as currently written, would prohibit state and local
22	governments from issuing tax-exempt advance refunding bonds. Advance refunding bonds are
23	bonds that are issued to refinance outstanding tax-exempt debt more than 90 days prior to the
24	date the refinanced debt is repaid. The bill would eliminate the ability to issue tax-exempt bonds
25	to advance refund outstanding bonds. This prohibition would apply to advance refunding bonds
26	issued after December 31, 2017; and
27	
28	WHEREAS, this legislative change would limit the ability of state and local governments
29	to lock in interest rate savings while rates are low and avoid the risk of rates having increased by
30	the time the outstanding bonds are permitted to be repaid; and
31	
32	WHEREAS, the Mayor and City Commission of the City of Hallandale Beach find that the
33	ability to refinance has resulted in millions of dollars in savings over the past several years and
34	the proposed legislation would impair state and local government's ability to save money for its
35	citizens and taxpayers.

37 38 39	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

40	SECTION 1. The foregoing "whereas" clauses are incorporated herein.
41	
42	SECTON 2. The Mayor and City Commission hereby urge the United States Congress to
43	remove the appropriate sections of both of the House and Senate bills related to advance
44	refunding of tax-exempt bonds.
45	
46	SECTION 3 . The City Clerk is directed to transmit a copy of this Resolution to all
47	appropriate parties.
48	
49	SECTION 4 . Effective Date. This resolution shall be effective immediately upon its
50	adoption.
