19	greater than ten thousand (\$10,000) dollars; and

21	WHEREAS, the proposed guidelines increase the amount of the yearly mini-grants for
22	smaller projects/programs, and for newly established not-for-profits or programs from five
23	thousand (\$5,000) dollars to ten thousand (\$10,000) dollars; and

25	WHEREAS, the Mayor and City Commission jointly with the Board of Directors of the
26	HBCRA desire to establish a Community Partnership Grants Committee with members appointed
27 28	by both the City Commission and HBCRA Board of Directors; and

Adoption of Grant Guidelines and establishment of Joint Community Partnership Grant Committee. The Mayor and City Commission and the Board of Directors of the HBCRA hereby jointly adopt the Grant Guidelines for the combined City/HBCRA Community Partnership Grant Program and establish the Joint Community Partnership Grants Committee based on the criteria set forth in the Grant Guidelines attached hereto as Exhibit 3.
