Furthermore, 25 pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the 26 authority to recommend to the City Commission award of contracts; and 27 28 WHEREAS, on October 13, 2017, the City released Re-Bid FY 2016-2017-009-001, 42nd Year Community Development Block Grant Public Works Stormwater 29 30 Improvements Project; and 31 32 WHEREAS, on November 16, 2017, a Mandatory Pre-Bid Conference was held at 33 11:00 AM and fourteen (14) vendors were in attendance; and WHEREAS, three (3) bids were received from Metro Express, Inc., Southeastern 34 Engineering Contractors, and F.H. Paschen, S.N. Nielson & Associates, LLC; and 35 36 37 WHEREAS, Metro Express, Inc. was the lowest responsive bid at one hundred 38 seventy five thousand nine hundred and forty three dollars (\$175,943); and 39 40 WHEREAS, the City Administration recommends that the City Commission award Re-Bid FY 2016-2017-009-001, 42nd Year Community Development Block Grant Public 41 Works Stormwater Improvements Project to the lowest responsive responsible bidder, 42 Metro Express, Inc., in an amount not to exceed one hundred seventy five thousand nine 43 hundred and forty three dollars (\$175,943) plus a ten percent (10%) contingency for 44 45 unforeseen circumstances.
