**RESOLUTION NO. 2018-**

WHEREAS, the City of Hallandale Beach ("City") administers a Community Benefits Program ("CBP") which included the use of local workforce and local vendor goals for both City projects and Hallandale Beach Community Redevelopment Agency ("HBCRA") projects which result in the alleviation of slum and blight within the HBCRA Community Redevelopment Area; and

**WHEREAS**, based upon the Needs Assessment recently completed by BRHPC, the City and the HBCRA desire to create a new viable, accountable and transparent CBP; and

WHEREAS, HBCRA staff recommends engaging Garth Solutions, Inc. ("GSI") to provide professional services for the development of a new CBP program based on the BRHPC Needs Assessment findings, and to assist the City with monitoring and administration of the CBP, as well as the establishment of concrete deliverables, timeframes and enforcement mechanisms, for a contract amount not to exceed \$\_\_\_\_\_\_\_, which contract amount will be paid by the City and HBCRA in proportions as determined by the City Manager and Executive Director; and

WHEREAS, the Board of Directors of the HBCRA desires to authorize the Executive Director and HBCRA Attorney to negotiate an agreement with GSI to provide professional services for the development of a new CBP for an amount not to exceed \$\_\_\_\_\_\_, which contract amount will be paid by the City and HBCRA in proportions as determined by the City Manager and Executive Director.
