14	WHEREAS, on January 26, 2018, the Governor issued an executive order		
15	suspending Mayor Joy Cooper pending the resolution of criminal charges, leaving only a		
16	bare minimum of commissioners, three (3), on the commission; and		
17			
18	WHEREAS, Florida Statutes Sec. 112.51(3) requires that the temporary vacancy		
19	left by Mayor Cooper's suspension be filled in the manner prescribed by the City Charter		
20	for permanent vacancies; and		
21			
22	WHEREAS, the City Charter requires that "whenever there is a vacancy in the		
23	commission and there are less than twelve (12) months remaining before the next regular		
24	city or general election, the city commission, by a majority vote of the remaining members,		
25	shall choose a successor to serve until that election;" and		
26			
27	WHEREAS, the commission must appoint an individual to temporarily fill the		
28	vacancy until November 2018. At the general election in November, in addition to the		
29	scheduled open seats of #1 and #2, the ballot will include an election to fill the vacancy of		
30	the Mayor until the earlier of (1) the end of Mayor Cooper's term in November 2020 or (2)		
31 32	she is reinstated by the Governor.; and		
33	WHEREAS, the City Charter and City Code require only a majority of the remaining		
34	members to approve the appointment of a qualified individual; and		
35			
36	WHEREAS, after its appointment of a new commissioner to fill a vacancy in May		
37	2014, the commission authorized Resolution 2014-61 formalizing the process it had used		

as the process to be used in future appointments but did intend these requirements to bind future commissions and not codify these requirements so that they may be revised or rescinded by future commissions; and				
WHEREAS, in light of the extraordinary circumstances arising from two vacancies leaving only a bare minimum of commissioners and potentially endangering the ability to conduct city business, the Commission desires to repeal Resolution 2014-61 in its entirety; and				
WHEREAS, pursuant to the nomination process the Commission undertook on February 13, 2018, the Commission appoints the Acting Mayor to the seat of the Mayor and further appoints Mr. Richard Dally to the vacancy subsequently created in commission seat two (2).				
NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
