14	WHEREAS, Section 20-18 of the City of Hallandale Beach Code provides that
15	the City Manager may recommend that the City Commission declare any City-owned
16	property which is no longer needed for public use and has a value in excess of
17	\$20,000.00 to be surplus property. Section 20-18 further provides that any City property
18	declared to be surplus by the City Commission may be disposed of in the manner
19	declared by the City Commission, including but not limited to sealed bids, auction and
20	negotiated sale; and
21	
22	WHEREAS, on June 20, 2006, the property located at 310 Ansin Boulevard, Folio
23	Number #5142-28-66-0010 was purchased by the City with the intent of utilizing the
24	property as a waste transfer station and storage facility for the City's Public Works
25	Department; and
26	
27	WHEREAS, since its acquisition, the City has explored numerous options
28	pertaining to the development of the property. Based on an analysis of current uses in
29	the area as well as recommended use and an appraisal completed by The Urban Group,
30	the property's highest and best use is as an industrial site; and
31	
32	WHEREAS, the City Manager recommends the City Commission declare the
33	property located at 310 Ansin Boulevard to be surplus property; and
34	
35	WHEREAS, at the August 30, 2017 City Commission Budget Workshop, the City
36	Commission recommended disposition of the site so the greatest net revenue may be

realized, and recommended the City procure through a Request for Proposals a

38	commercial real estate brokerage specializing in the sale of industrial properties for the
39	disposition of the property; and

41	WHEREAS, the Mayor and City Commission have determined that it is in the best
42	interest of the residents of the City of Hallandale Beach to declare the property located at
43	310 Ansin Boulevard to be surplus property and to authorize its disposal by commercial
44	real estate brokerage firm procured through a Request for Proposals.

46	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY
47	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

49	SECTION 1. Declaration of Surplus Property. The Mayor and City
50	Commission hereby declare the property located at 310 Ansin Boulevard, Folio Number
51	#5142-28-66-0010 is no longer needed for public use and is surplus property.
52	
53	SECTION 2. Authorizing Disposal by Brokerage Firm procured by Request
54	for Proposals. The Mayor and City Commission hereby authorize the City Administration
55	to dispose of the property located at 310 Ansin Boulevard by obtaining the services of a
56	commercial real estate brokerage firm procured through a Request for Proposals.

58	<b>SECTION 3. Effective Date.</b> This Resolution shall take effect immediately upon
59	its passage and adoption.
