2 3 4 5 6 7 8 9 110 111 112 113 114 115	A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH HAZEN AND SAWYER, INC., FOR THE SCOPE OF SERVICES PROVIDED IN EXHIBIT 4 FOR DESIGN AND PERMITTING OF THE WATER TREATMENT PLANT HIGH SERVICE PUMPS PHASE I FOR AN AMOUNT NOT TO EXCEED THREE HUNDRED NINETY-NINE THOUSAND, NINE HUNDRED FORTY-NINE (\$399,949.00) DOLLARS; FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PROJECT; AND PROVIDING AN EFFECTIVE DATE.
17	WHEREAS, on January 25, 2017, the City Commission approved Resolution 2017-06
18	awarding RFP # FY2015-2016-025 CCNA Design Service Pumps and Transfer Pumps at the
19	City's Water Treatment Plant to Hazen and Sawyer, Inc.; and
20	
21	WHEREAS, Resolution 2017-06 authorized the City Manager and the City Attorney to
22	negotiate an agreement with Hazen and Sawyer and to bring back for City Commission approval;
23	and

25	WHEREAS, the scope of work to be provided shall include the design, permitting,
26	assistance with bidding and construction oversight assistance for the replacement of the high
27	service pump stations (HSPs); and
28	
29	WHEREAS, the design, permitting, assistance with bidding and construction oversight
30	assistance was budgeted in Fiscal Year (FY) 2015-2016 in the amount of four hundred thousand
31	(\$400,000.00) dollars; and
32	
33	WHEREAS, the preliminary construction costs are estimated to be two million seven
34	hundred thousand (\$2,700,000.00) dollars. However, the necessary funding has been divided
35	over the course of Fiscal Year 2016-2017 in the approved budgeted amount of one million, three
36	hundred-fifty thousand dollars (\$1,350,000.00) dollars and for Fiscal Year 2017-2018 a budget
37	request subject to City Commission approval will be submitted in an amount of one million, three
38	hundred-fifty thousand (\$1,350,000.00) dollars; and

WHEREAS, the City Administration recommends the City Commission authorize the City Manager to execute an agreement with Hazen and Sawyer, Inc. for the scope of services provided in Exhibit 4 for design and permitting of the Water Treatment Plant High Service Pumps Phase I in an amount not to exceed Three Hundred Ninety-Nine Thousand, Nine Hundred Forty-Nine (\$399,949.00) dollars. NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA: **SECTION 1.** City Manager's Authorization. The Mayor and City Commission hereby authorize the City Manager to execute an agreement with Hazen and Sawyer, Inc. for the scope of services provided in Exhibit 4 for design and permitting of the Water Treatment Plant High Service Pumps Phase I in an amount not to exceed Three Hundred Ninety-Nine Thousand, Nine Hundred Forty-Nine (\$399,949.00) dollars. Further authorizing the City Manager to take all necessary to effectuate the project. SECTION 2. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
