15	WHEREAS, the City of Hallandale Beach Public Works Department ("Department") is		
16	seeking to obtain accreditation from the American Public Works Association ("APWA"); and

18	WHEREAS, the APWA has developed a self-assessment and accreditation process to		
19	enhance the effectiveness of agencies and ensure their competency in the delivery of public		
20	works operations and services. The APWA Accreditation process provides a framework for		
21	strategic planning; and

23	WHEREAS, during the accreditation process, the Department will gather documentation		
24	which may include but is not limited to contracts, agreements, ordinances, organizational charts,		
25	and standard operating procedures (SOPs) to support compliance with the various practice areas		
26	defined in the program. The Department will identify areas of deficiencies and take corrective		
27	measures by developing SOPs, establishing ordinances, and modifying existing processes. The		
28	process will last between twelve (12) to thirty-six (36) months based on the Department's resource		
29	availability; and

31	WHEREAS, the cost of the APWA accreditation process is based on a fee structure		
32	defined in the application. The City will be charged a fee of \$11,300 to complete the accreditation		
33	process; and

35	WHEREAS, the City Administration recommends the City Commission authorize the City		
36	Manager to execute a contract with APWA to complete the APWA accreditation process for an		
37	amount not to exceed eleven thousand three hundred dollars (\$11,300).
