21	was created and inspired the building of a model for pet-friendly cities, advocating for
22	fewer pets in shelters, more pet-friendly places, and happier, healthier lives for both
23	people and pets; and
24	WHEREAS, in collaboration with Vice Mayor M. Lazarow, the City plans to
25	pursue a possible grant of \$20,000, the maximum grant for a city with a population under
26	75,000, to take advantage of this grant opportunity.
27	WHEREAS, the only cost involved with the grant is a trip for the Mayor or
28	designee to the award ceremony if the City is selected as the winning applicant.
