45	SECTION 4. Control. In the event of a conflict or conflicts between this Ordinance and			
46	any other ordinance, or between this Ordinance and a provision of the Florida Election Code,			
47	Chapters 97-106, Florida Statutes that does not expressly apply to municipalities, or any other			
48	provision of law, this Ordinance controls to the extent allowable under the law.
