4 AN ORDINANCE OF THE MAYOR AND CITY COMMISSION OF
5 THE CITY OF HALLANDALE BEACH, FLORIDA; CALLING
6 FOR A GENERAL ELECTION ON NOVEMBER 6, 2018 TO
7 ELECT THE SEATS OF COMMISSIONER SEAT #1 AND
8 COMMISSIONER SEAT #2 TO THE CITY COMMISSION FOR A
9 FOUR YEAR TERM; SETTING THE QUALIFYING PERIOD FOR
10 COMMENCEMENT ON JUNE 18, 2018 AT 8:00 AM AND
11 ENDING ON JUNE 22, 2018 AT 12:00 PM; PROVIDING FOR
12 SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

14 **WHEREAS**, Section 4.01 of the City of Hallandale Beach Charter provides that the City
15 Commission, by ordinance and subject to the provision of its Charter, shall have the power to
16 call Regular and Special Elections as may be required by the City; and

18 **WHEREAS**, the terms of Commissioner Seat # 1 and Commissioner Seat # 2 will expire
19 upon the November 2018 General Election, whereby the electorates of the City will elect at-
20 large Commissioners to these seats for a four (4) year term; and

22 **WHEREAS**, Section 4.06 of the City of Hallandale Beach Charter provides that a
23 general city election for the purpose of electing members to the City Commission shall be held
24 on the first Tuesday after the first Monday in November of each even-numbered year; and

26 **WHEREBY**, City Administration has determined it is in the best interest of the City to set
27 the qualifying period for the General Election to commence on June 18, 2018 at 8:00 am and end
28 on June 22, 2018 at 12:00 pm, with notice of such election transmitted to the Broward County
29 Supervisor of Elections; and

30 **WHEREAS**, the Mayor and the City Commission have determined that it is in the best
31 interest of the residents of the City to call for a General Election to elect the seats of
32 Commissioner Seat #1 and Commissioner Seat #2 for a four year term on November 6, 2018, and
33 to set the qualifying period for the General Election to commence on June 18, 2018 at 8:00 am
34 and end on June 22, 2018 at 12:00 pm.

35 **NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND CITY COMMISSION OF**
36 **HALLANDALE BEACH, FLORIDA:**

SECTION 1. The Mayor and City Commission of the City of Hallandale Beach hereby call for a General Election to elect the seats of Commissioner Seat #1 and Commissioner Seat #2 for a four year term on November 6, 2018.

SECTION 2. The Qualifying Period for all candidates will commence on June 18, 2018 at 8:00 AM and end at noon on June 22, 2018.

SECTION 3. The City Clerk is authorized and directed to publish notice of the election, as required by law, and to take all other measures necessary to conduct the election.

SECTION 4. Control. In the event of a conflict or conflicts between this Ordinance and any other ordinance, or between this Ordinance and a provision of the Florida Election Code, Chapters 97-106, Florida Statutes that does not expressly apply to municipalities, or any other provision of law, this Ordinance controls to the extent allowable under the law.

SECTION 5. This Ordinance shall become effective immediately upon passage by the City Commission on second reading.
