15	WHEREAS, Broward County and the Cities in the County have entered into three		
16	Interlocal Agreements ("ILA's") providing for the division and distribution of the proceeds		
17	of the local option gas taxes imposed by Broward County by ordinance; and		
18			
19	WHEREAS the distribution of local option gas taxes as provided for by the ILAs		
20	are based on population figures published annually by the University of Florida Bureau of		
21	Economics and Business Research; and		
22			
23	WHEREAS, the ILAs authorize the annual revision of city shares in the local option		
24	gas tax proceeds based on the most current published population numbers; and		
25			
26	WHEREAS, the City and County's populations have increased, creating the need		
27	to adjust its cities' shares of the local option gas tax proceeds; and		
28			
29	WHEREAS, the proposed 2018 amendments to the 1994 and 2001 ILAs (the		
30	"Amendments") adjust the City's share of the local option gas tax proceeds based on the		
31	population increases in the City and in Broward County; and		
32			
33	WHEREAS, the 2018 amendment to the three cents "additional" local option gas		
34	tax agreement provides that the Cities' share remains at 51.27 percent and the City of		
35	Hallandale Beach's share decreased from 1.076284% to 1.068610% due to the county		
36	population increase; and		
37			
38	WHEREAS, the 2018 amendment to the one cent "transit gas tax" includes		
39	adjustments to each City's percentage share based on updated population figures, with 1 RESO. NO. 2018 –		

40	the City's share decreased from 0.545804% to 0.541913% due to the county population		
41	increase; and		
42			
43	WHEREAS, the Mayor and City Commi	ssion have determined that it is in the best	
44	interest of the residents of the City of Hallandale Beach to execute the 2016 amendments		
45	to the three cent and one cent Local Gas Tax Interlocal Agreements with Broward County		
46	for the division and distribution of the proceeds of the local option gas taxes imposed by		
47	Broward County; and		
48			
49	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY		
50	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

52	SECTION 1. City Manager Authoriz	ation. The Mayor and City Commission	
53	hereby authorize the City Manager to execute the amendments to the Interlocal		
54	Agreements with Broward County for the division and distribution of the local option gas

56	Exhibits "1A" and "2A"; and
