23	WHEREAS, on July 28, 2016, the City released Invitation to Bid #FY 2015-2016-021,
24	Sidewalk Repairs and Other Related Services seeking sealed bids from licensed contractor(s) for
25	a three (3) year contract on an as needed basis for sidewalk repairs and other related services;

28	WHEREAS, on November 16, 2016, pursuant to Resolution No. 2016-182, the City
29	Commission awarded ITB #FY2015-2016-021, Sidewalk Repair And Other Related Services to
30	the lowest responsive, responsible, bidder Metro Express, Inc. in an amount not to exceed one
31	hundred thirty three thousand six hundred twenty five (\$133,625.00) dollars, the amount for the
32	first year of the three year contract; and

34	WHEREAS, the City Administration recommends authorizing the contract with Metro
35	Express, Inc. awarded pursuant to ITB #FY2015-2016-021 for the second and third years of the
36	term for an expenditure of one hundred thirty three thousand six hundred twenty five
37	(\$133,625.00) dollars per year for FY2017-2018 and FY2018-19; and
