### Short Title:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE PURCHASE OF THE TI TRAINING SIMULATOR AT A COST NOT TO EXCEED EIGHTY TWO THOUSAND THREE HUNDRED AND FIVE DOLLARS (\$82,305) PURSUANT TO THE COMPETITIVELY OBTAINED CONTRACT OF MIAMI-DADE COUNTY; AND PROVIDING FOR AN EFFECTIVE DATE.

## **Staff Summary:**

### **Background:**

The Hallandale Beach Police Department (HBPD) has a strong commitment to developing the skills and abilities of all its law enforcement officers through a comprehensive training curriculum. Over the past year, the department has invested in the training unit by adding a police sergeant and increasing the amount of training hours an officer must undergo per year. Part of that commitment is the repurposing of a room to be utilized for training. This training room, which has already been constructed, is now ready to house the training simulator and be outfitted with mats and equipment for defensive tactics training. Once completed, the training room will be used to train officers in a multitude of scenarios to challenge their decision making under stressful situations and changing conditions.

### **Analysis:**

Based on the direction provided by the City Commission on September 12, 2016, the Police Department began to research numerous scenario based firearms simulators while completing the construction of the training room. After consulting with surrounding agencies and reviewing the product from various vendors, it became evident the Training Lab Use of Force Training Simulator from Ti Training Corporation is the best product for our agency. The system utilizes the latest advancements in video, laser, radio frequency and programming technology to provide an intuitive, easy to maintain training tool. This training tool is designed to aid in teaching public safety personnel how to effectively and safely perform their duties. The course begins with classroom theory and progresses to "hands on" proficiency based exercises.

The Ti Training Simulator is currently being utilized by the Broward Community College Institute of Public Safety. This college is where we send our police recruits and also where we train our sworn officers utilizing this system. Our trainers are proficient with its operations and functionality.

Miami Dade County procured the Ti Training Simulator in 2017 via competitive solicitation and awarded contract # EPPRFP-00485 (Exhibit 2). The contract remains valid, and staff is requesting to piggyback this contract. The TI Training Simulator will be purchased as specified in the attached proposal (Exhibit 3) in accordance with the contract.

### **Fiscal Impact:**

The fiscal impact of purchasing the Training Lab Use of Force Simulator is \$82,305. The cost includes the complete Training Lab Use of Force Simulator, the Master Instructor Course and the equipment to allow officers to train utilizing the use of force tools they currently carry on duty.

**Why Action is Necessary:**

Pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6) Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure all supplies, materials, equipment and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval.

**Proposed Action:**

Staff recommends approval of the attached resolution authorizing the City Manager to piggyback Miami Dade County Contract # EPPRFP 00485 – Law Enforcement Training Simulator, to procure the Training Lab Use of Force Simulator from Ti Training Corp. in an amount not to exceed \$82,305.


