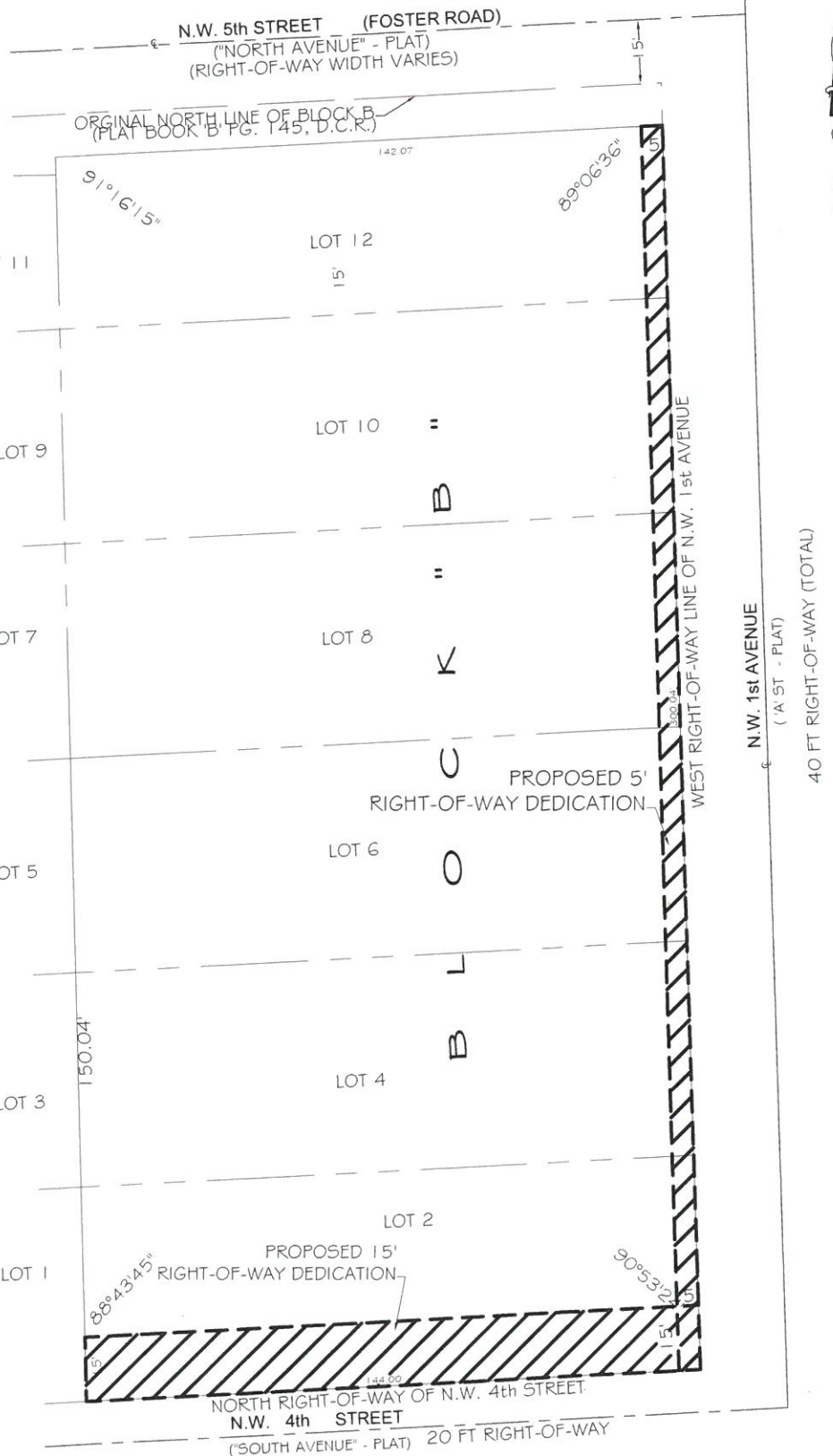


RIGHT-OF-WAY DEDICATION

PHIPPEN'S SUBDIVISION OF PART OF BLOCK 16 AND 4, VALENTINE'S SURVEY OF HALLANDALE FLORIDA", ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK B, PAGE 145, OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA.



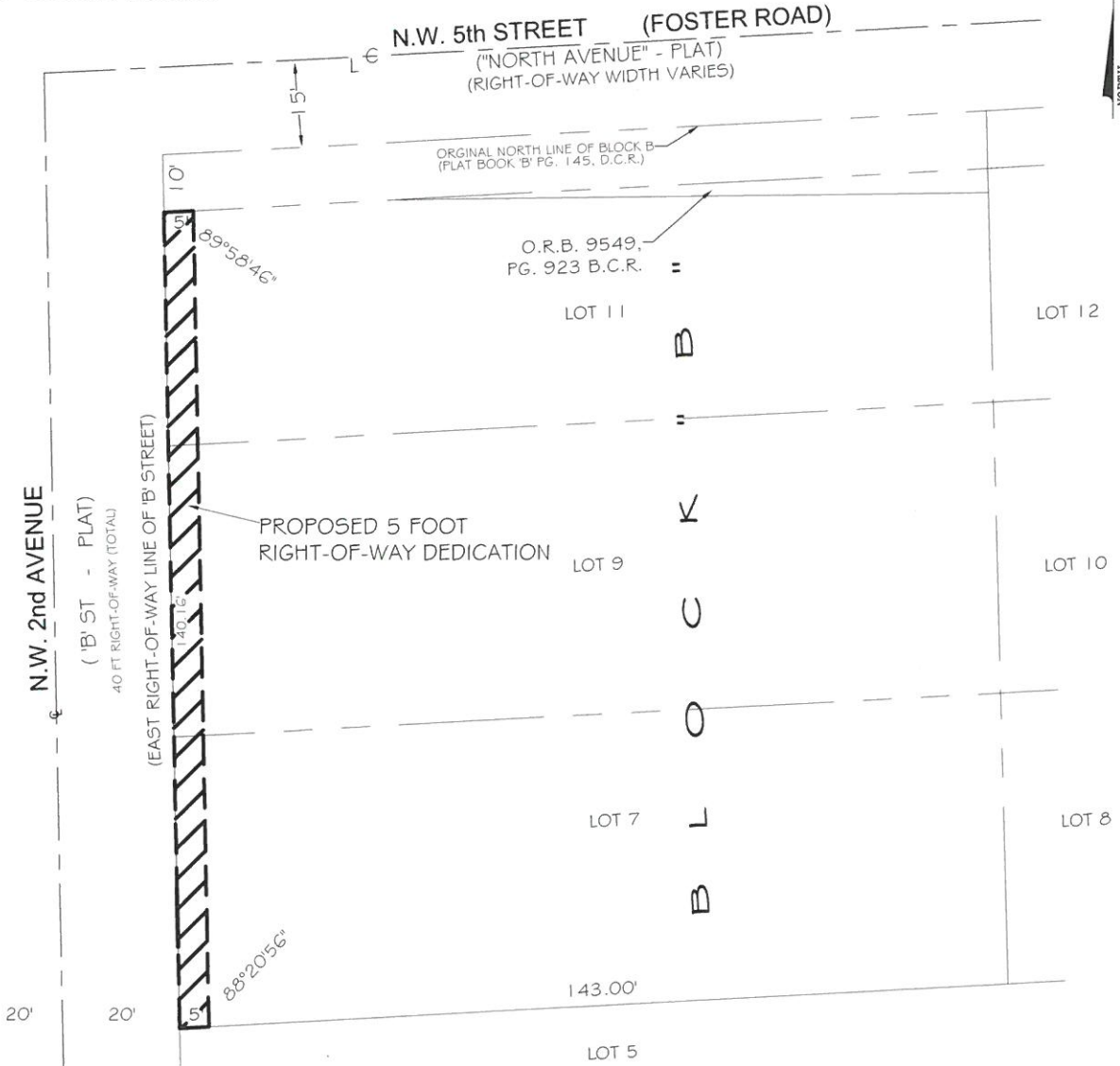
