19	WHEREAS, Resolution No. 2017-116 authorized an expenditure for an amount not to					
20 21	exceed four hundred seventy five thousand one hundred fifty dollars (\$475,150); and					
22	WHEREAS, there has been an unanticipated increase in per gallon cost of fuel from an					
23 24	average of \$1.97 to \$2.21 for unleaded fuel and an average of \$1.93 to \$2.31 for diesel fuel; and					
25	WHEREAS, City Administration anticipates that the total Fiscal Year 17-18 expenditure					
26	will require an increase by one hundred twenty thousand dollars (\$120,000) in order to continue					
27	to purchase diesel fuel and unleaded gasoline until the end of the fiscal year; and

29	WHEREAS, pursuant to Section 23-12 of the City Code of Ordinances, change orders by					
30	more than either ten percent of the contract cost or in excess of \$50,000 require the approval of
