14	WHEREAS, the applicant, Romagnole Investment Properties LLC is requesting approval
15	to amend the existing Non-Vehicular Access Line (NVAL) to the Hallandale Oasis Plat located
16	at 1000-1100 East Hallandale Beach Boulevard; and

18	WHEREAS, the requested modification to the NVAL along East Hallandale Beach
19	Boulevard coincides with the driveway widths and locations on the site plan for the Hallandale
20	Oasis project as approved by the City Commission pursuant to Resolution No. 2018-035 on
21	May 2, 2018, and as required and approved by the Florida Department of Transportation
22	(FDOT); and

24	WHEREAS, the City is required to transmit resolutions for revisions to the NVAL to
25	Broward County for approval in accordance with Chapter 5, Article IX of the Broward County
26	Code of Ordinances; and

28	WHEREAS, the Mayor and City Commission have determined that approval of the
29	proposed revision to the NVAL within the Hallandale Oasis Plat is in the best interest of the City,
30	and will not adversely affect the public health, safety and welfare.
31	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION
32	OF THE CITY OF HALLANDALE BEACH, FLORIDA:

34	SECTION 1. The foregoing "whereas" clauses are incorporated herein.

36	SECTION 2. Approval of Revision of the Non-Venicular Access Line.
37	and City Commission of the City of Hallandale Beach, Florida, hereby approve the revision of
38	the NVAL within the Hallandale Oasis Plat, as depicted in attached Exhibit "6".
39	SECTION 3. Authorization to Transmit Revision of the Non-Vehicular Access
40	Line. The Mayor and City Commission of the City of Hallandale Beach, Florida, hereby
41	authorize the City Manager to transmit the resolution to Broward County for approval in
42	accordance with Chapter 5, Article IX of the Broward County Code of Ordinances.

44	SECTION 4. Conditions of Approval. This approval is subject to all existing
45	application procedures and ordinances of the City, and approval by Broward County. If there is
46	any conflict between the location of the NVAL depicted in Exhibit "6" and the NVAL depicted in
47	the site plan as approved by Resolution No. 2018-035, the NVAL in the site plan shall
48	supersede and the legal description of the NVAL shall be amended accordingly.
49	SECTION 5. Effective Date. This Resolution shall take effect immediately upon its
