30	mills within the Golden Isles Safe Neighborhood District.

32	SECTION 3. Approval of GISND Annual Budget. The Chair and Board of		
33	Directors hereby approve the annual budget submitted by the GISND for FY 2018/19 at		
34	\$348,770, within the Golden Isles Safe Neighborhood District.
