A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING HUBERT JACKSON FOR THE 2019 DR. MARTIN LUTHER KING, JR. HUMANITARIAN AWARD; AND PROVIDING FOR AN EFFECTIVE DATE.

Staff Summary:

Background:

Annually, the Human Services Department accepts applications for the Dr. Martin Luther King, Jr. Humanitarian Award (Exhibit 2). The Award is bestowed upon the person or organization chosen from the applications submitted from the community. In the past, and pursuant to administrative policy, the applications were reviewed by the Human Services Advisory Board, who selected a candidate and made the recommendation to the City Commission. The City Commission ratified the Board's recommendation. Since the sunset of the Human Services Advisory Board, the Interim City Manager appointed the City's Grant Review Committee to serve as the Committee to review the Dr. Martin Luther King, Jr. Humanitarian Award Nomination Applications. The Grant Review Committee is comprised of Beverly Sanders Mayweather, Human Services Director; Larette Alexander, Human Services Administrative Coordinator; Marie "Maggie" Gouin, Budget Director; Nydia M. Rafols Sallaberry, Interim City Manager; Lovern Parks, CRA Program Manager; Andrea Lues, Procurement Director and Faith Phinn, Community Resident Appointment.

City Officials and the City Manager are ineligible for consideration of this award. However, City Advisory Board members and City employees whose contributions are performed as an individual or as a member of an organization, outside of City of Hallandale Beach board and/or job duties, are eligible for consideration of this award.

In August 2018, Nomination Application Forms (Exhibit 3) were placed at every City Department, Advisory Boards, City Website, Social Media, local businesses, churches and schools throughout the City of Hallandale Beach. The deadline for completed nominations to be submitted to the Human Services Department was September 10, 2018.

Current Situation:

On Friday, September 14, 2018, the Grant Review Committee met to review the nominations and selected a recipient for the 2019 Dr. Martin Luther King, Jr. Humanitarian Award. After reviewing the applications, the Grant Review Committee recommended Hubert Jackson as the 2019 recipient of the Dr. Martin Luther King, Jr. Humanitarian Award.

Mr. Jackson has been serving in the Hallandale Beach Community for more than 58 years. Outside of being a record breaking, achieving member of the Dixie Park Swim Team and a retired City Employee with over 30 years of service, Mr. Jackson volunteers his time teaching swim lessons, coaching football, mentoring the youth, and being a community activist. Mr. Jackson is an excellent role model for the youth and provides

assistance to the elderly in the community. Mr. Jackson's love for sports is demonstrated by his involvement in Parks activities and Police Athletic League (PAL) Programs. In addition, Mr. Jackson is an active deacon/member in the church. He is known as "Hammer the Historian" to both his family and the City of Hallandale Beach. He has extensive knowledge of the City of Hallandale Beach. He loves to speak and share history at various City events and with the community at large. He has a passion for giving back to the Hallandale Beach community. He served his country in the tour of duty during the Vietnam War. Mr. Jackson has a gift of writing poetry, which he shares through Speaking Hands at various occasions and City events.

Mr. Jackson will be honored at the Annual Community Civic Association, Inc. Dr. Martin Luther King, Jr. Scholarship Breakfast. The breakfast will be held on January 12, 2019 at the Hallandale Beach Cultural Center.

Fiscal Impact:

The fiscal impact is the cost involved to purchase a plaque that will be presented to the recipient once ratified by the City Commission. The estimated cost of the plaque is approximately \$100.

Why Action is Necessary:

The Human Services Department is seeking City Commission ratification of the Grants Review Committee's selection of Hubert Jackson as the 2019 Dr. Martin Luther King, Jr. Humanitarian Award recipient.

Proposed Action:

Staff recommends the approval of the attached resolution ratifying the Committee's nomination of Hubert Jackson as the recipient of the 2019 Dr. Martin Luther King, Jr. Humanitarian Award. The Dr. Martin Luther King, Jr. Humanitarian Award recipient will be presented with a plaque at the December 12, 2018 Commission Meeting. Other nominees will be presented with a Certificate of Recognition.
