Short Title:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, DECLARING A UNIQUE CIRCUMSTANCE PURSUANT TO SECTION 23-8(5), EXCEPTION TO BID REQUIREMENTS, AUTHORIZING THE CITY MANAGER TO EXECUTE A MULTI-YEAR AGREEMENT WITH AT&T FOR INTERNET CONNECTIVITY SERVICES IN AN AMOUNT NOT TO EXCEED SIXTY FIVE THOUSAND DOLLARS (\$65,000.00) ANNUALLY; AND PROVIDING FOR AN EFFECTIVE DATE.

Staff Summary:

Background:

This is a new contract proposal with AT&T that will allow the City of Hallandale Beach to achieve cost efficiency for better internet and voice services and better rates. This pricing is substantially less than the same service of 100 Mbps under GSA Schedule 70 GSA Contract number GS-35F-0249J. The Innovation Department proposes to achieve substantial savings from the current costs delivered today.

Current Situation:

The City of Hallandale Beach wishes to procure internet connectivity services with AT&T under unique circumstances, as their services has been far more resilient than other vendors that own telecommunications infrastructure within the City of Hallandale Beach. We have tried telecommunications services with other contractors, and have experienced failures of service and minimal level of resiliency.

Why Action is Necessary:

Pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (5) Unique circumstances, where the City Commission finds unique circumstances to establish that competitive bidding is not in the best interest of the City. Purchases in excess of \$50,000 require a formal, written contract approved by the City Commission.

Fiscal Impact:

The fiscal impact is estimated to be \$65,000 as provided in the Fiscal Year Budget 18/19.

Proposed Action:

Staff recommends approval of the attached Resolution authorizing the Interim City Manager to execute related documents to efecutate the purchase of Wireless Internet & Voice Communication Services utilizing the attached contract, Exhibit 2, through the approved AT&T Corp vendor for FY 2018-2019.
