L6	Circumstances, the City Commission may declare unique circumstances as an exception to the

L9	WHEREAS, the reliability of internet connectivity services varies by area and is dependent		
20	on the specific infrastructure in an area. AT&T has been far more resilient than other vendors		
21	that own telecommunications infrastructure within the City of Hallandale Beach. The City has tried		
22	telecommunications services with other contractors, and has experienced failures of service an		
23	minimal levels of resiliency; and

25	WHEREAS, City Administration recommends a finding of unique circumstances to		
26	authorize the procurement of internet connectivity services with AT&T and		
27			
28	WHEREAS, AT&T has proposed a multi-year agreement that will allow the City realize		
29	significant savings while obtaining better services. The proposed pricing is substantially less than		
30	the same service of 100 Mbps under the State of Florida GSA Schedule 70 GSA Contract number		
31	GS-35F-0249J; and

33	WHEREAS, the Mayor and City Commission have determined that it is in the best interest		
34	of the City and its residents to authorize the City Manager enter into a multi-year agreement with		
35	AT&T for internet connectivity services.
