9 10	THOUSAND FIVE HUNDRED (\$104,500) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL			
11	RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE;			
12 13	AND PROVIDING FOR AN EFFECTIVE DATE.

15	WHEREAS, pursuant to Section 23-8(6) "Exception to Bid Requirements" of the City of			
16	Hallandale Beach ("City") Code, the City Manager is authorized to use competitive bids and formal			
17	contracts from other entities when the best interests of the City would be served, subject to the			
18	requirement that any purchase in excess of \$50,000 requires City Commission approval; and			
19				
20	WHEREAS, the Broward Sheriff's Office ("BSO") Logistics Warehouse procures a variety			
21	of items for the Fire and Police Departments in large quantities and can therefore obtain significant			
22	discounts; and			
23				
24	WHEREAS, the BSO Logistics Warehouse must comply with the purchasing requirements			
25	of the Broward Sheriff's Office, including the obtaining of bids, and will sell supplies to			
26	municipalities at cost; and			
27				
28	WHEREAS, the day to day supplies of the Fire Department are continuous and Fire			
29	Department staff can reasonably estimate, based on historical data and current budgets, that			
30	expenditures with BSO logistics for FY18 will exceed the City Manager's spending authority; and			
31				
32	WHEREAS, the estimated cost of goods to be procured from the BSO Logistics			
33	Warehouse for the Fire and Police Departments in FY 2018-19 is one hundred four thousand five			
34	hundred (\$104,500) dollars; and			
35				
36	WHEREAS, the City Administration requests authorization to procure the necessary			
37	equipment and supplies from the BSO Logistics Warehouse for the Fire and Police Departments			

38 39 40	in the total amount of one hundred four thousand five hundred (\$104,500) dollars as it is in the best interest of the City of Hallandale Beach and its residents; and
41	WHEREAS, the Mayor and City Commission find that it is in the best interest of the City
42	of Hallandale Beach to be able to obtain the necessary equipment from the BSO Logistics
43	Warehouse.

45	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
46	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
47	
48	SECTION 1. The foregoing "Whereas" clauses are hereby confirmed as true and
49	incorporated herein.
50	
51	SECTION 2. City Manager Authorization. The Mayor and City Commission hereby
52	authorize the City Manager to procure equipment and supplies from the Broward Sheriff's Office
53	Logistics warehouse for the Fire and Police Department in an amount not to exceed one hundred
54	four thousand five hundred (\$104,500) dollars.
55	
56	SECTION 2. Effective Date. This Resolution shall take effect immediately upon its
57	passage and adoption.
