**RESOLUTION NO. 2018 -121**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURCHASE EQUIPMENT AND SUPPLIES FOR THE FIRE AND POLICE DEPARTMENTS FROM THE BROWARD SHERIFF'S OFFICE LOGISTICS WAREHOUSE IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FOUR THOUSAND FIVE HUNDRED (\$104,500) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Section 23-8(6) "Exception to Bid Requirements" of the City of Hallandale Beach ("City") Code, the City Manager is authorized to use competitive bids and formal contracts from other entities when the best interests of the City would be served, subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

**WHEREAS**, the Broward Sheriff's Office ("BSO") Logistics Warehouse procures a variety of items for the Fire and Police Departments in large quantities and can therefore obtain significant discounts; and

**WHEREAS**, the BSO Logistics Warehouse must comply with the purchasing requirements of the Broward Sheriff's Office, including the obtaining of bids, and will sell supplies to municipalities at cost; and

**WHEREAS**, the day to day supplies of the Fire Department are continuous and Fire Department staff can reasonably estimate, based on historical data and current budgets, that expenditures with BSO logistics for FY18 will exceed the City Manager's spending authority; and

**WHEREAS**, the estimated cost of goods to be procured from the BSO Logistics Warehouse for the Fire and Police Departments in FY 2018-19 is one hundred four thousand five hundred (\$104,500) dollars; and

**WHEREAS**, the City Administration requests authorization to procure the necessary equipment and supplies from the BSO Logistics Warehouse for the Fire and Police Departments

in the total amount of one hundred four thousand five hundred (\$104,500) dollars as it is in the best interest of the City of Hallandale Beach and its residents; and

**WHEREAS**, the Mayor and City Commission find that it is in the best interest of the City of Hallandale Beach to be able to obtain the necessary equipment from the BSO Logistics Warehouse.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby confirmed as true and incorporated herein.

**SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby authorize the City Manager to procure equipment and supplies from the Broward Sheriff's Office Logistics warehouse for the Fire and Police Department in an amount not to exceed one hundred four thousand five hundred (\$104,500) dollars.

**SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.
