34	WHEREAS, TLC Diversified Inc. was the lowest responsive bid at an amount no			
35	to exceed four million six hundred eighty eight thousand six hundred twenty five dollar			
36	(\$4,688,625); and

38	WHEREAS, the City Administration recommends that the City Commission awar

61	eight hundred seventy seven thousand one hundred twenty eight dollars (\$4,877,128)			
62	inclusive of a 3.87% contingency for unforeseen circumstances. The City Manager is			
63	further authorized to negotiate and execute all related documents to effectuate this project.
