16	WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach ("City")
17	Code, the City Manager shall have the authority to join with other units of government in
18	cooperative purchasing plans or to purchase pursuant to formal written contracts or
19	competitive bids of other governmental units, when the best interests of the City would be
20	served, subject to the requirement that purchases in excess of \$50,000 require City
21	Commission approval; and
22	
23	WHEREAS, on January 14, 2015, the Florida Sheriff's Association ("FSA") formally
24	advertised Invitation to Bid No. 15/17-07-0220 to establish a contract for the purchase of
25	tires; and
26	
27	WHEREAS, as a result of this bid process, Bid Contract #15/17-07-0220 ("FSA
28	Bid Contract") was awarded by the FSA to the following vendors: Bridgestone,
29	Continental, Goodyear, Michelin and Trelleborg; and
30	
31	WHEREAS, Addendum #1 was released on January 31, 2017, which extended
32	the FSA Bid Contract for an additional two (2) year period beginning on March 1, 2017
33	and ending on February 28, 2019, and which removed Trelleborg as a listed vendor; and
34	MUEDE AO the Other and a graph of the second and a second a second and
35	WHEREAS, the City customarily utilizes cooperative purchasing contracts in order
36	to provide cost savings and cost avoidances that would otherwise be impossible for the
37	City realize. As such, the City has decided to purchase tires utilizing authorized vendors
38	from the FSA for the 2018-2019 fiscal year; and

40	WHEREAS, the City Administration concluded it is cost effective and in the best		
41	interest of the City to purchase tires through cooperative purchasing from the FSA Bid		
42	Contract for an amount not to exceed one hundred ten thousand dollars (\$110,000) for

45	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

47 48	SECTION 1. City Manager Authorization. The Mayor and City Commission		
49	hereby authorize the utilization of the Florida Sheriff's Association Bid Contract #15/17-		
50	07-0220 to purchase tires and other optional services for an amount not to exceed one		
51	hundred ten thousand dollars (\$110,000) as provided for in fiscal year 2018-2019 budget,		
52	and further authorize the City Manager to execute all related documents to effectuate the		
53	purchase.
