

RESOLUTION NO. 2018- 137

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT FOR FEDERAL LOBBYIST SERVICES WITH ALCAD E & FAY, FOR AN AMOUNT NOT TO EXCEED FIFTY THOUSAND (\$50,000) DOLLARS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements.

(4) No bid received. Where no bid has been received after publication of a bid proposal; however, such purchases in excess of \$50,000.00 require a formal, written contract approved by the City Commission; and

WHEREAS, the City has maintained a professional services agreement with Alcalde & Fay for Federal Lobbyist services since December 2012. This agreement was awarded through a Request for Proposal (RFP) #2011-2012-019, Federal Lobbyist Services, on December 5, 2012; and

WHEREAS, RFP # FY 2017-2018-018 Federal Lobbyist Services was released September 25, 2018, but no qualified responses were received; and

WHEREAS, Alcalde & Fay has agreed to maintain their current fee for federal lobbyist services at \$50,000 per fiscal year, for a total contract value of \$150,000 over three years; and

WHEREAS, Alcalde & Fay’s legislative experience and legislative and federal administrative contacts and expertise have supported the City in its efforts to achieve key federal legislative and grant funding goals; and

WHEREAS, the Mayor and City Commission have determined that it is in the best interest of the City to authorize the City Manager to negotiate an agreement with Alcalde & Fay.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing “Whereas” clauses are incorporated herein.

SECTION 2. City Manager and City Attorney Authority. The Mayor and City Commission hereby authorize the City Manager to execute a three year contract with Alcade & Fay, to provide federal lobbyist services to the City of Hallandale Beach, Florida in an amount not to exceed \$50,000.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
