15	competitive bids and formal contracts of other governmental units when the best interests of the
16	City would be served, subject to the requirement that any purchase in excess of \$50,000.00
17	requires City Commission approval; and

19	WHEREAS, the State of Florida entered into an agreement with EAN Services (also
20	known as Enterprise Rent-a-Car) by way of the Florida Department of Management Services
21	(FDMS) in EAN Services Contract #78111808-15-1; and

23	WHEREAS, the City of Hallandale Beach Police Department's (HBPD) Neighborhood
24	Enforcement Team (N.E.T.) and the Vice, Intelligence and Narcotics (V.I.N.) Units officers have
25	an ongoing need to rent vehicles for their day to day operations. The ability to maintain an active
26	rotation of unmarked, indistinguishable "police" vehicles for use in patrol and undercover
27	operations makes it less likely that officers are recognized, which is a key element to the success
28	of such operations, as well as for officer safety; and

30	WHEREAS, the City Administration request authorization to piggy-back the Florida
31	Department of Management Services (FDMS) EAN Services Contract #78111808-15-1, as may
32	be further amended, for rental cars, for an amount not to exceed of one hundred six thousand
33	eight hundred and sixty (\$106,860) dollars.
