23	prepared by Bermello Ajamil & Partners, Inc.; and

25	WHEREAS, the City-wide Parks Master Plan proposes minimal changes to Ingalls Park,
26	stating that the present park layout and venues are in consonance with the community needs and
27	desires; and

29	WHEREAS, as per Florida Statute 287.055, if an agency project has an estimated
30	construction cost of less than \$2 million, or the study/design services is less than \$200,000, an
31	agency may utilize the services of a consultant through a Continuing Services Contract; and

33	WHEREAS, Synalovski Romanick Saye, LLC is listed as the next available firm on the
34	City's continuing services contract rotation list; and

36	WHEREAS, the City Administration requests the Mayor and City Commission authorized
37	the City Manager to issue a work authorization to Synalovski Romanick Saye, LLC to design
38	permit and provide plans for the Ingalls Park project in an amount not to exceed one hundred
39	eighty six thousand (\$186,000.00) dollars; and
